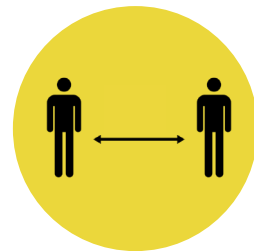

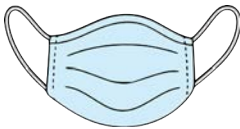


Health & Wellbeing Protocols

FPMA plans to execute the following best practices to help attendees stay healthy and reduce exposure and risk:



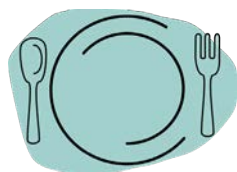
SAM 2022 attendees will be encouraged to wear masks throughout the conference.



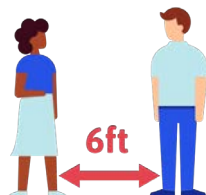
Hand sanitization stations will be available throughout the conference. Attendees are encouraged to utilize frequently.

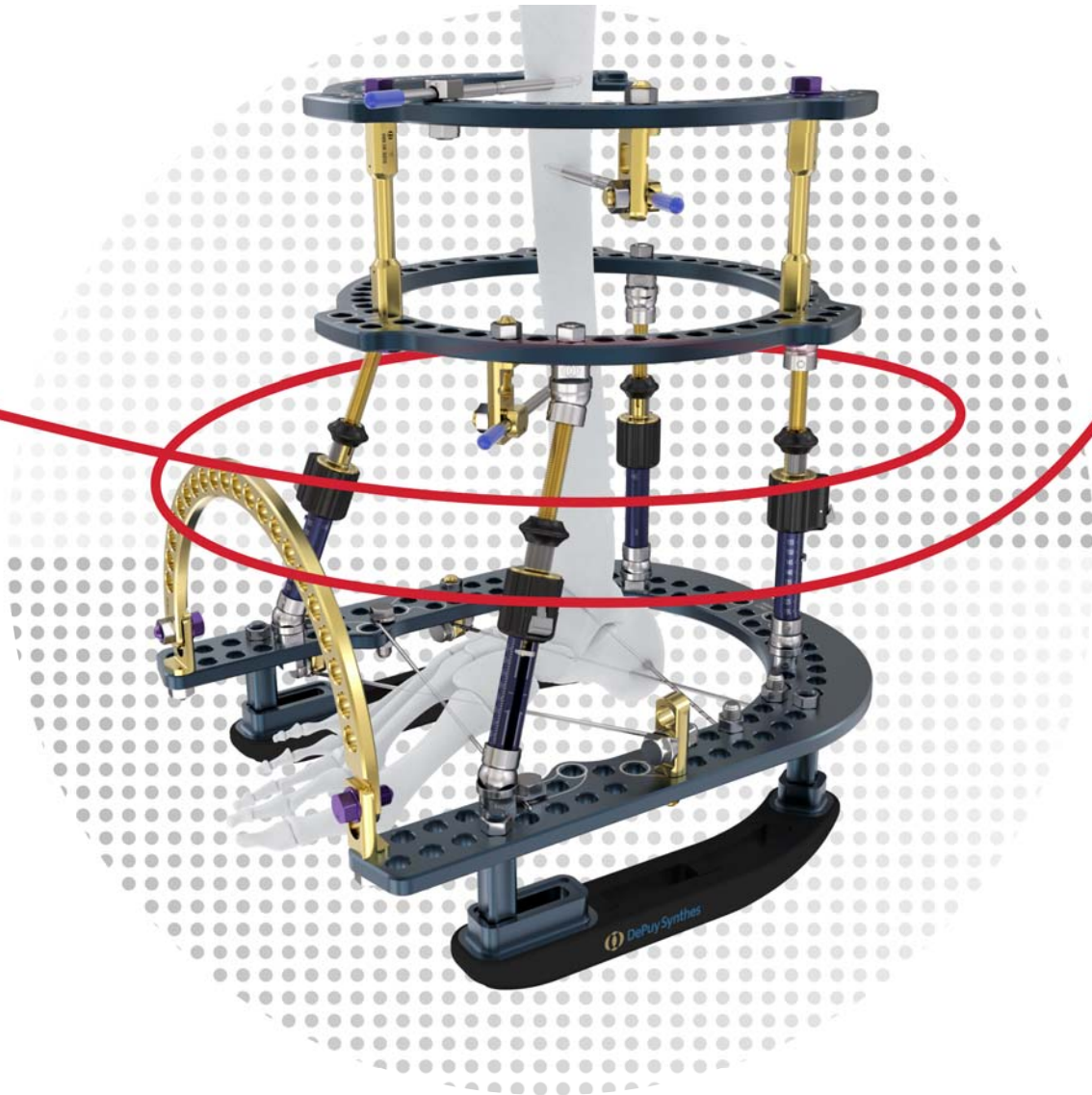

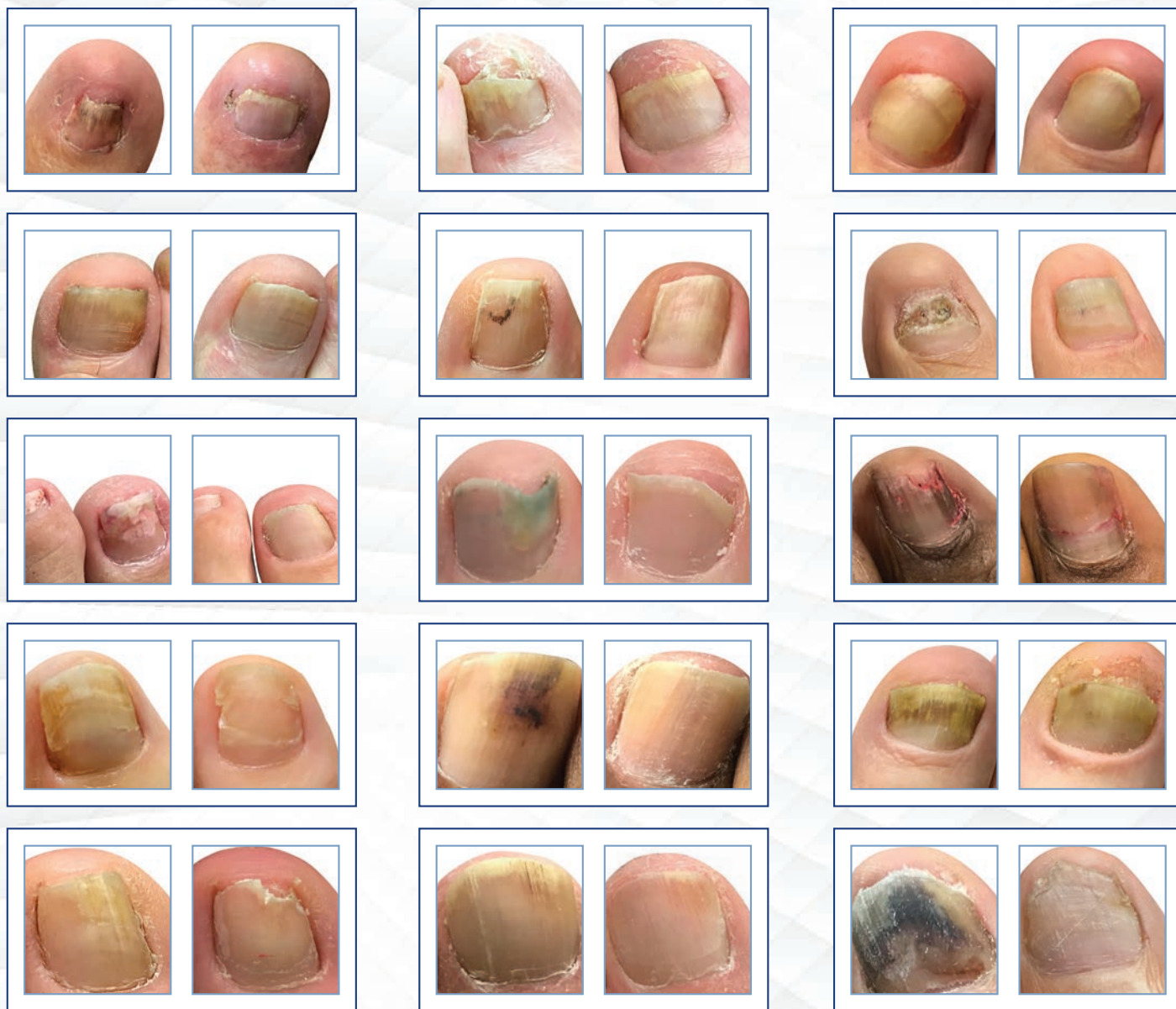

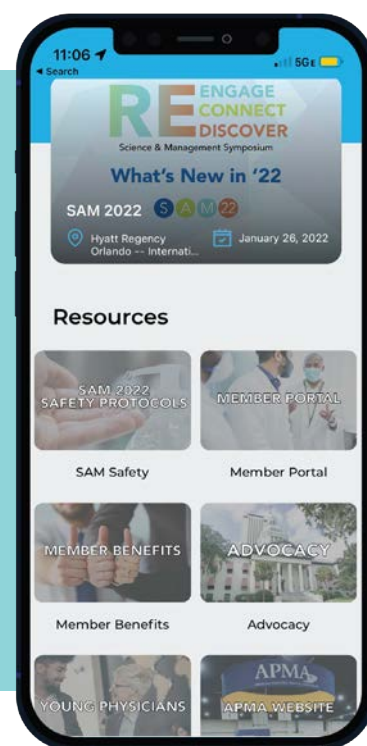

Attendance Verification

VERIFICATION PROCESS

Podiatric Physician attendees will enter verification codes into the FPMA Mobile App as a means of touchless scanning.

These verification codes will be announced at the conclusion of EVERY lecture.

Although the touchless method is most encouraged to ensure safety protocols, every physician attendee will also receive a scanning name badge upon check-in at the SAM registration desk. For physicians, attendance will need to be verified during each lecture to determine exact duration and assign Continuing Education Contact Hours (CECH) accordingly.

Attendees will be awarded CECH for the lectures for which their attendance is verified.

GENERAL INFORMATION

Total CECH will be calculated from each physician's attendance verification records. These hours will be submitted to CE Broker by FPMA at the conclusion of the conference, once all hours have been verified, and for FPMA Members, all 2021 membership dues have been paid in full. Florida Podiatric Physicians can view these hours via their CE Broker account at www.cebroke.com. Podiatric Physicians from other states will be sent certificates showing total CECH earned by attending SAM 2022.

SAM 2022 attendees will be awarded up to 32.0 Continuing Education Contact Hours. Continuing Education Contact Hours (CECH) are calculated hour-per-hour based on courses attended (time taken for breaks and meals are NOT counted); e.g., a 30 minute Science lecture will earn 0.5 Science credit hours, a one-hour Science lecture will earn 1.0 Science credit hours, a 1.5 hour Practice Management lecture will earn 1.5 PM credit hours, etc.

All licensees who seek to renew the active status of their licensure must demonstrate that they have completed, during the previous two years, at least forty (40) hours of continuing education, including the following categories:

- At least one (1) of the forty (40) hours must concern the topic of Risk Management.
- At least one (1) of the forty (40) hours must be on the topic of Laws and Rules.
- At least two (2) of the forty (40) hours must be on the subject of prevention of Medical Errors.
- At least two (2) of the forty (40) hours must be on Prescribing Controlled Substances.
- While not required, licensees may complete up to three (3) hours of continuing education per biennium in the area of Practice Management.
- The remainder of the hours can be made up of Scientific hours.



Accreditation Information

Podiatric Physician Accreditation Statement: FPMA is approved by the Council on Podiatric Medical Education (CPME) as a provider of continuing education in podiatric medicine. FPMA has approved this activity for a maximum of 32 Continuing Education Contact Hours (CECH) during this five-day conference, depending on lectures attended. This conference will take place January 26 - 30, 2022 at the Hyatt Regency Orlando - International Drive in Orlando, Florida.

In accordance with the Council on Podiatric Medical Education, FPMA is required to monitor educational session attendance for verification of CECH. Badges for attendance verification will be provided to each SAM 2022 Physician and X-Ray Assistant attendee when they check in at the conference.

CECH functions are for registered attendees only. CECH credits are based on attendance of educational sessions; sessions specified as "Non-CECH" in the conference program are not included in compiling CECH credits.

FPMA will provide attendees with a Certificate of Attendance that reflects only the number of CECH documented via their scanning badge records. CECH will be reported to CE Broker on behalf of SAM 2022 Physician and X-Ray Assistant attendees currently licensed in the state of Florida. Each attendee is responsible for reporting attendance to all appropriate boards and agencies requiring continuing education by providing a copy of their SAM 2022 Certificate of Attendance.

Certificate of Attendance: To ensure FPMA continues to provide a meaningful educational program and exceptional conference experience, FPMA requests all attendees complete an overall conference evaluation prior to receiving their Certificate of Attendance. Attendees will receive an email from FPMA with a link to complete the overall conference evaluation within three (3) weeks of the conclusion of the conference, pending all conference fees being paid and attendance verified by FPMA. The Certificate of Attendance will be provided for printing/downloading in PDF format once the overall conference evaluation is completed.

Non-APMA/FPMA members paid the full registration fee of \$975 (by November 23, 2021) or \$1,075 (after November 23, 2021).

Residents Case Presentation Competition and Poster Competition

RESIDENTS CASE PRESENTATION COMPETITION

The Florida Podiatric Medical Association (FPMA) is pleased to announce the 18th Annual Residents Forum taking place at the FPMA Science & Management Symposium (SAM 2022) on Friday, January 28, 2022 from 1:30 PM - 3:15 PM.

Like previous years, FPMA is requesting engaging cases to be presented in a PowerPoint format with a strict 7.5-minute time limit. We will award the top three presenters with winnings of \$500 (1st place), \$400 (2nd place), or \$300 (3rd place). The top 3 winners will be announced, and the 1st place winner will be asked to present, on Saturday, January 29, 2022.

Presentations will be graded based on:

- a) Quality of the oral presentation
- b) Rationale for procedure/fixation employed
- c) Lessons learned from the success/failure of the surgery
- d) Strict adherence to the 7.5-minute time limit

Residents must be FPMA/APMA members to participate. No more than two residents per residency program allowed to present.

POSTER COMPETITION

Submissions are for the SAM 2022 Poster Competition held January 27 - 29, 2022.

The top 3 poster winners will be awarded \$1000 (1st place), \$750 (2nd place), or \$500 (3rd place). The corresponding author for the winning poster will be asked to summarize their poster at the award presentation on Saturday, January 29, 2022.

Topics for posters should be based on lower extremity conditions/procedures/care and must include one podiatric physician as a lead author. The podiatric attendings, residents, young practitioners, and medical students listed as authors must be APMA/FPMA members in good standing. If a resident or student is the corresponding author, one attending must be registered for the SAM conference. If the participants formerly listed are not APMA/FPMA members, they must join APMA or be removed from the competition. Only in-state residency programs will be allowed to participate at this time.

Posters will not be judged within categories. Our judging criteria will use a point system. The top 3 posters will be awarded and presented on Saturday, January 29, 2022 in the main conference area.
